### **COMPULSORY ACQUISITION OF LAND**

**IRISH WATER COMPULSORY PURCHASE (ATHENRY SEWERAGE SCHEME NETWORK) ORDER, 2021**

#### **WHEREAS:-**

1. Irish Water (hereinafter referred to as "the Company"), a Water Services Authority for the purposes of the Water Services Act, 2007, proposes for the purposes of the Water Services Acts, 2007 to 2013 and in exercise of its powers under Sections 32 and 93 of the Water Services Act, 2007 to acquire compulsorily the lands and rights over land hereinafter described and has made an Order entitled as above which Order is dated 17 June 2021 and which Order was submitted to An Bord Pleanála (hereinafter "*the Board*") for confirmation.
2. No objections were received by the Board or the Company within the period provided for making objections.



3. By letter dated the 5 August 2021 the Board informed the Company that it had received no objections to the Order within the period provided for making objections and pursuant to Section 216(1) of the Planning and Development Act, 2000, as amended, that the Company could, as soon as may be, confirm the Order with or without modifications.

**NOW THIS CONFIRMATION ORDER WITNESSETH:-**

- (1) That in pursuance of Section 216(1) of the Planning and Development Act, 2000, as amended, and as applied to the Company by Section 93 of the Water Services Act, 2007, as amended, the Company **HEREBY CONFIRMS** the Order with the following modifications;

Plots: 134, 135 and 136 shall be removed from the schedule which lands are in the ownership of CLS Recruitment Group Ltd, Old Connolly Sports Building, Loughgeorge, Claregalway, Co. Galway and the occupation of Niall Murphy, Belville, Athenry, Co. Galway

Plots: 200 and 201 shall be removed from the schedule which lands are in the ownership of The Athenry Community Council Trust Company Limited By Guarantee C/O. J.M.G. Sweeney Solicitor, Cross Street, Athenry Co. Galway

Plot: 202 shall be removed from the schedule which lands are in the ownership of The Athenry Community Council Trust Company Limited By Guarantee C/O. J.M.G. Sweeney Solicitor, Cross Street, Athenry Co. Galway and the occupation of Galway County Council, Áras an Chontae, Prospect Hill, Galway, H91 H6KX

- (2) That the Company do acquire all the land and wayleaves, rights and liberties which the Company sought to acquire by and which are set out in the Order;
- (3) That the Company shall serve on the relevant owners, lessees and occupiers of all lands affected by the Order a Notice to Treat and a Notice of Entry as prescribed by the Housing Act, 1966, as amended.
